All About Love: Disclosure & Serodiscordant Couples

- The panelist introduced themselves to the participants- Ida Starks, Walldeline Francois, Dean Hutchins, Paolo Mancini, and Andres Acosta
- The panelist answered the following questions:
 - 1. What does "love" look like/mean to you?
 - 2. How do you prepare yourself to disclose and receive a response on your status to your partner? or family and friends
 - 3. What are the social misconceptions about serodiscordant couples that you would like to address/destigmatize?
 - 4. How can one's partner be an advocate for someone with HIV?
 - 5. Tell us about a positive experience that you have had with disclosing your status to a partner, friend, or family member.
- They discussed and shared the importance of self-love, staying hopeful while being receptive of the people that do express love, the influence of education, the impact of the U=U campaign, the power in transparency, the fact that all relationships have ups and downs regardless of status, and the significance in supporting your partner in the way that they would like to receive that support.
- They also answered some more questions such as their favorite thing or pet peeve their partner does, their love languages, and disclosing to a child.
