- A quality continuum of care for all individuals and families with, affected by, and at risk for HIV.



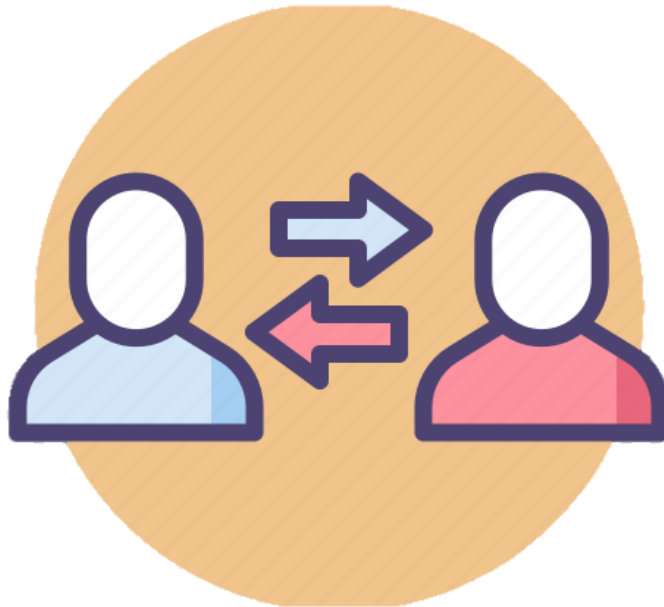
Mission Statement

- **Point of information:** Information request
- **Point of support:** A call for help
- **Point of clarification:** A call to clarify information that is not clear

- **PWH members without conflicts (i.e. does not work for a Ryan White HIV/AIDS Program funded organization)**
- **Race:** All
- **Gender:** Female, specifically women living with HIV with no conflicts
- **Age:** 20-29, 40-49 & 60+, specifically those without conflicts
- **Mandated Seats:** None
