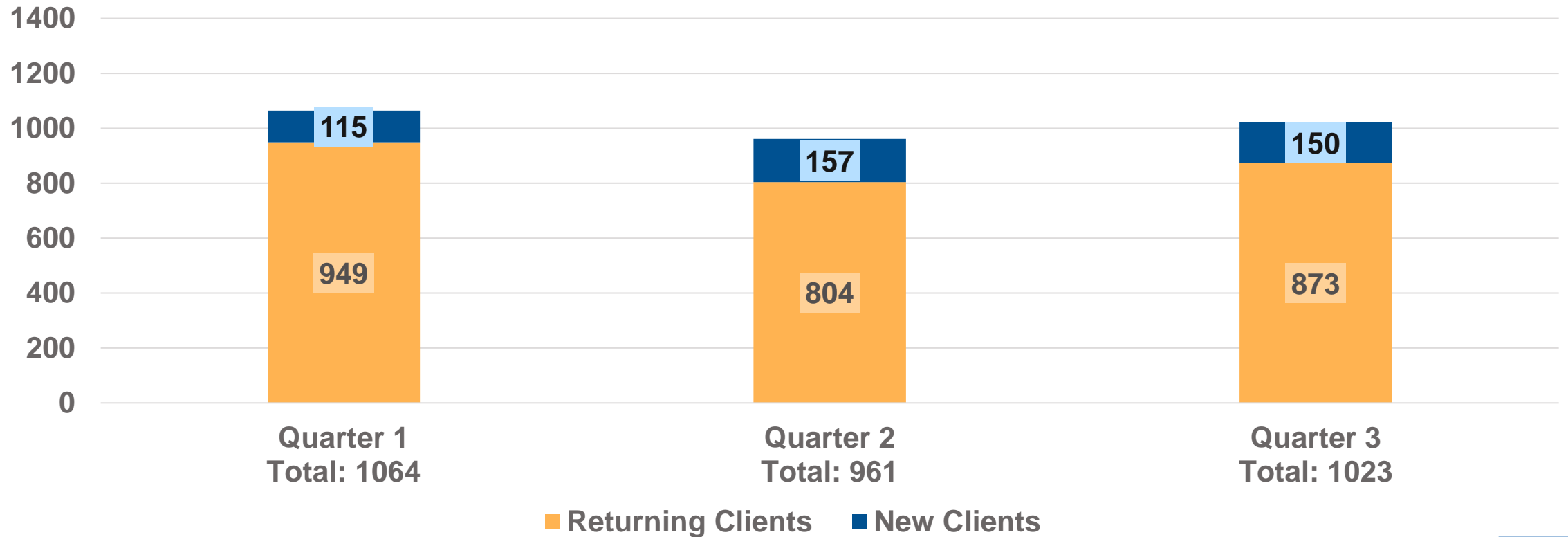

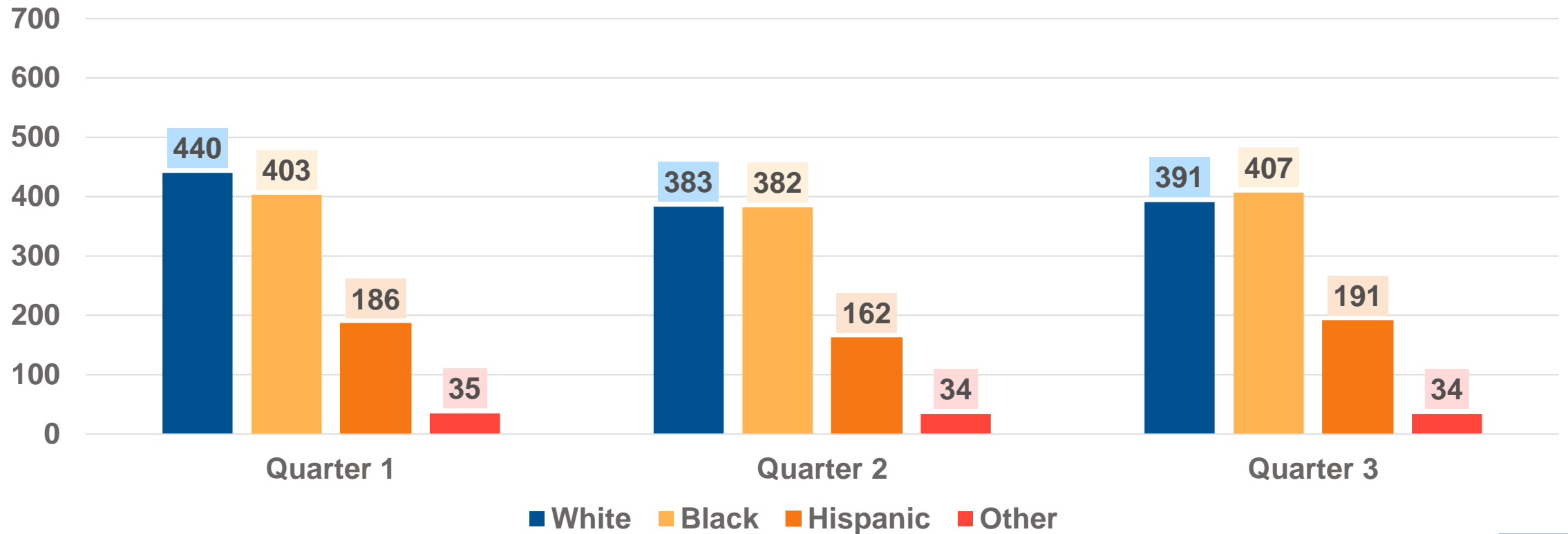

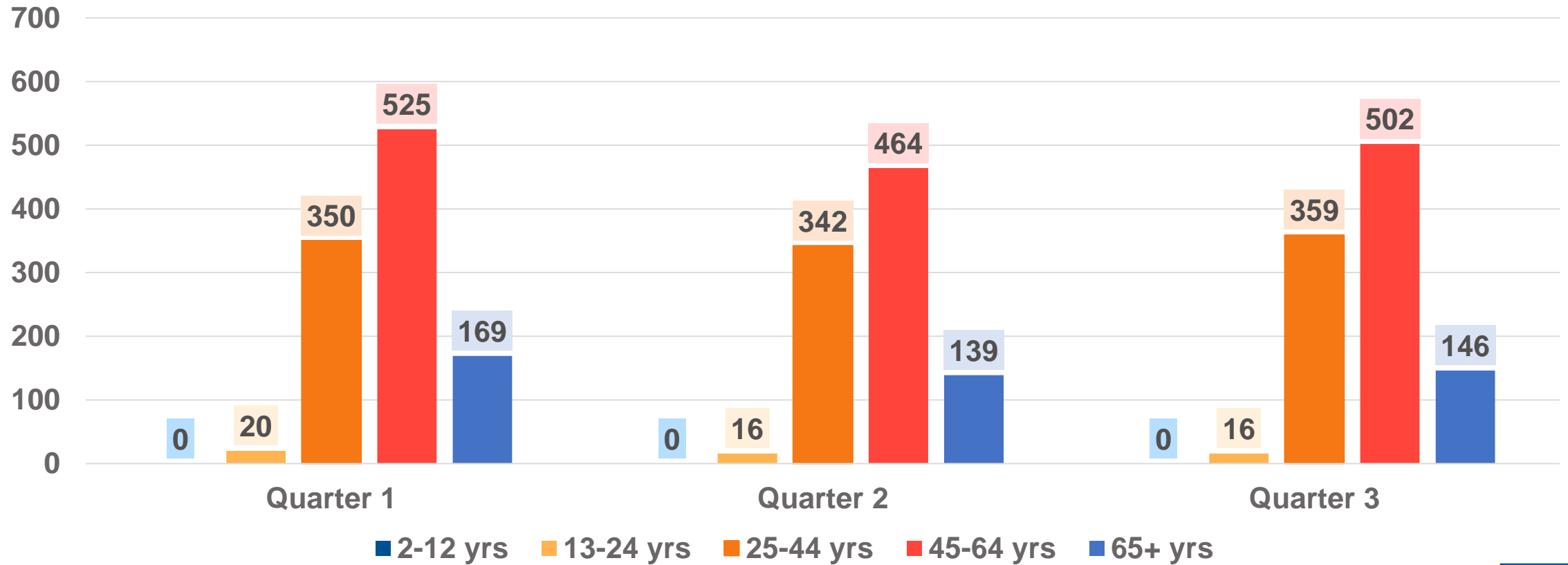
Part B 2024-2025 Quarter 3 Comparison by Gender



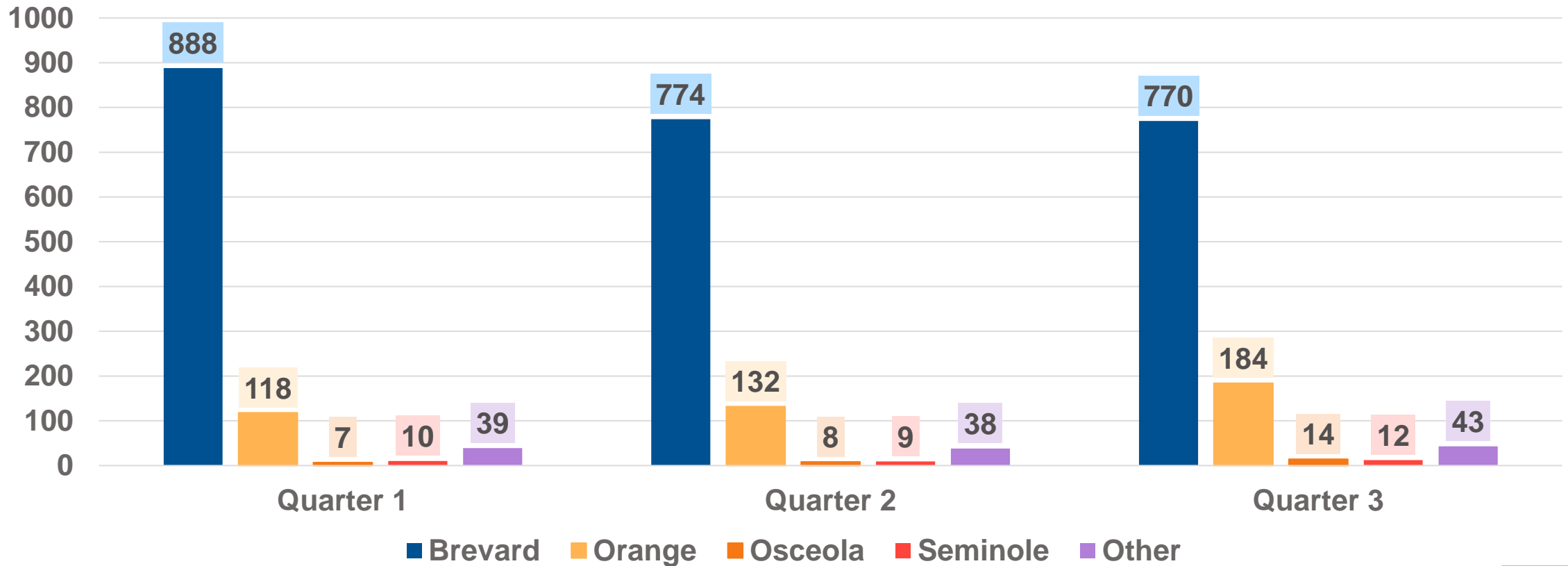
Comparison by Race & Ethnicity



Part B 2024-2025 Quarter 3 Comparison by Age



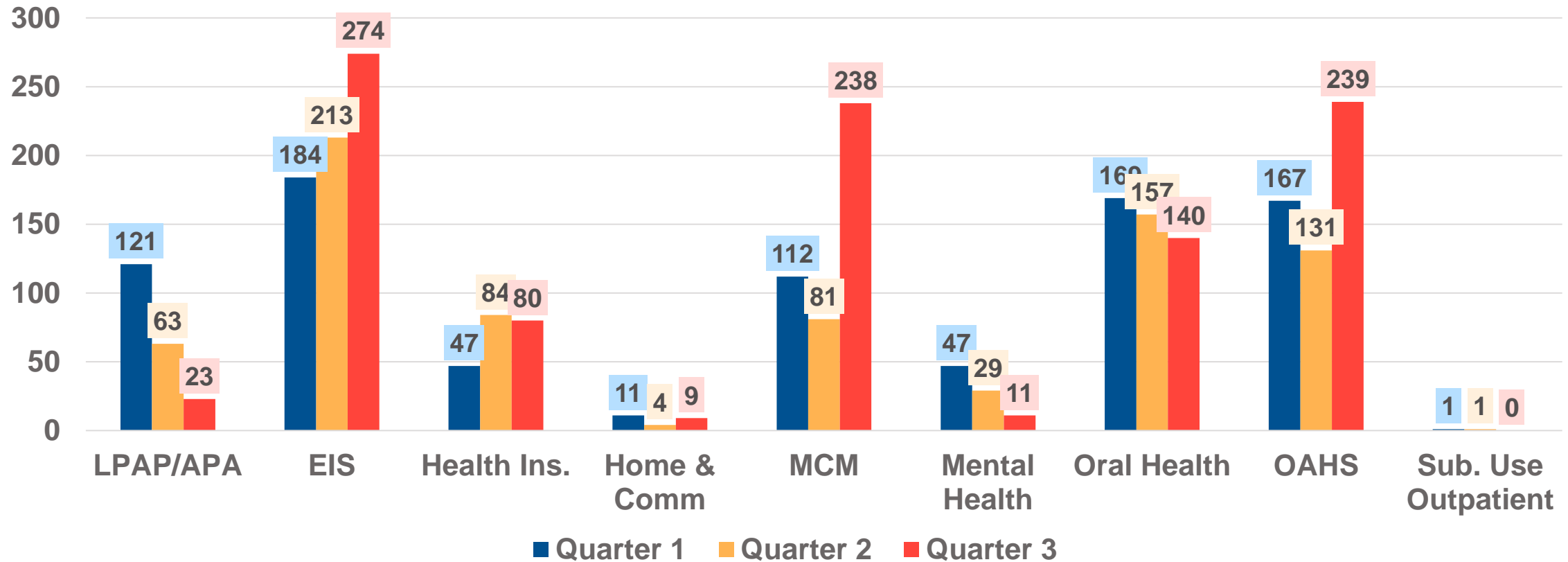
Part B 2024-2025 Quarter 3 Comparison by County



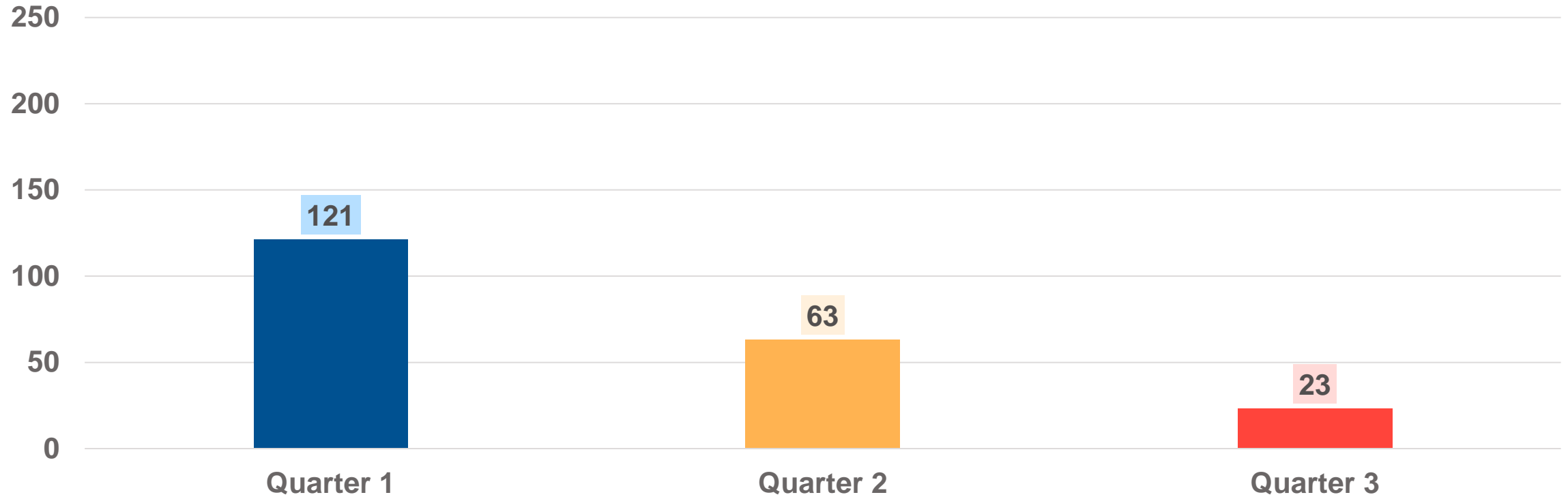

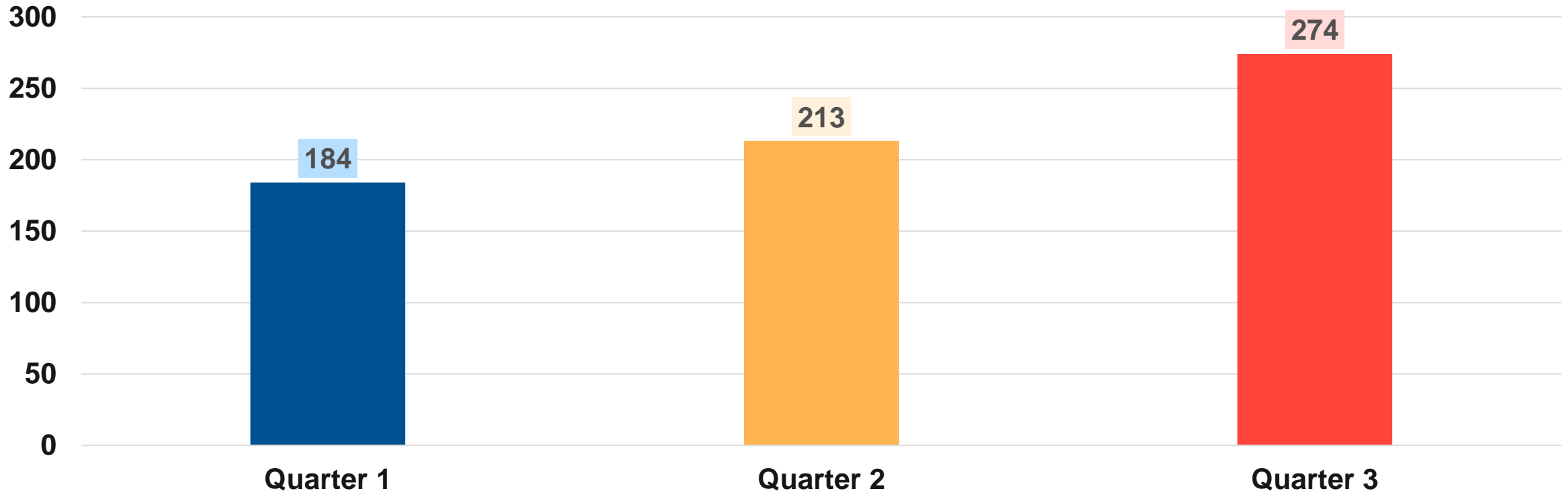

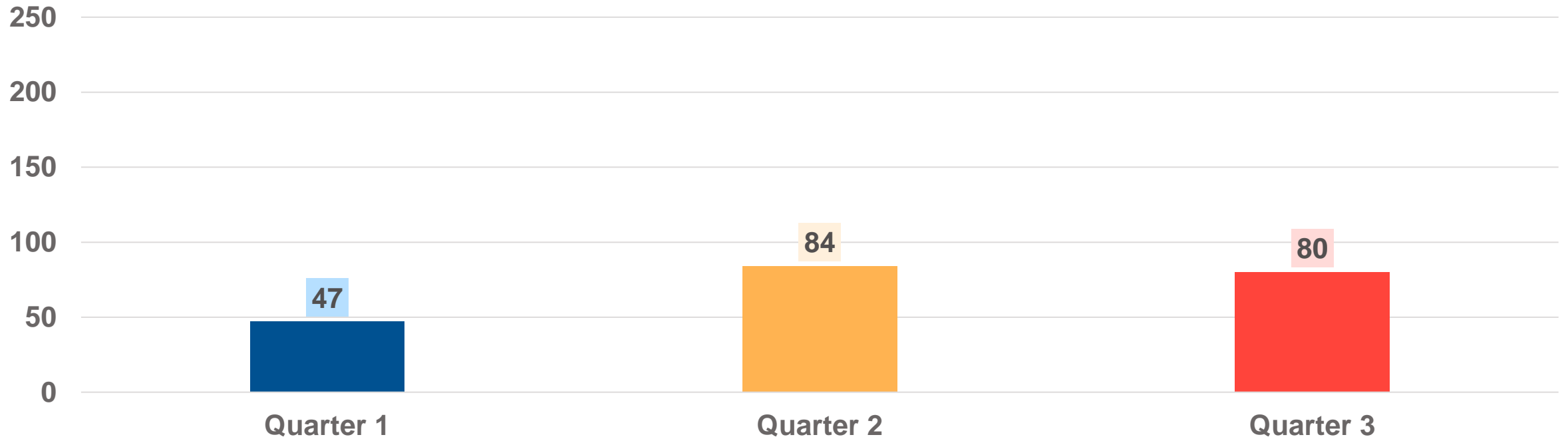

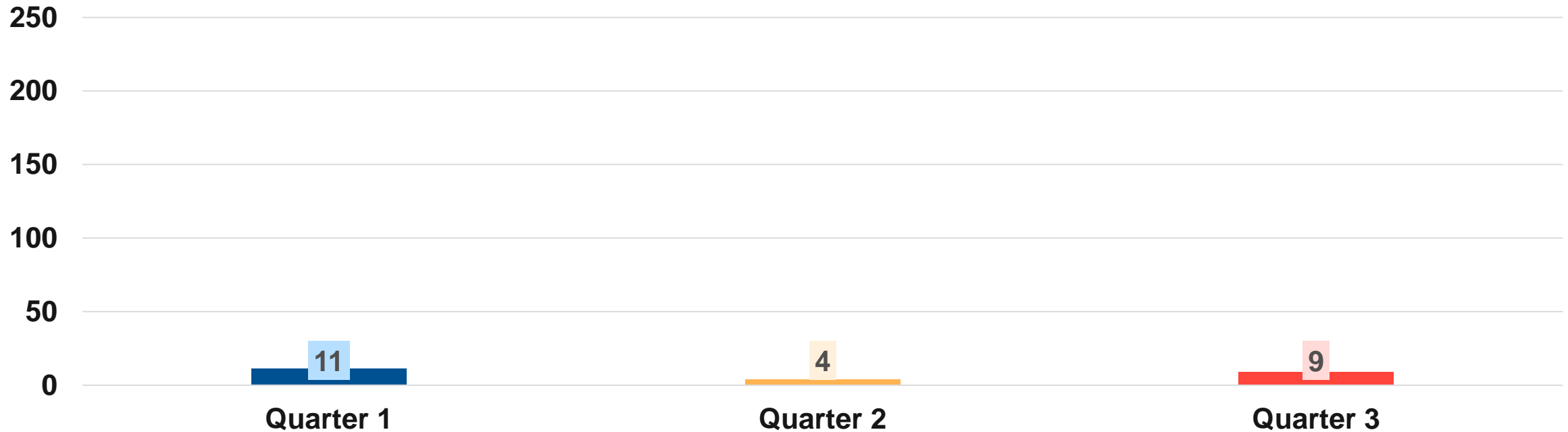

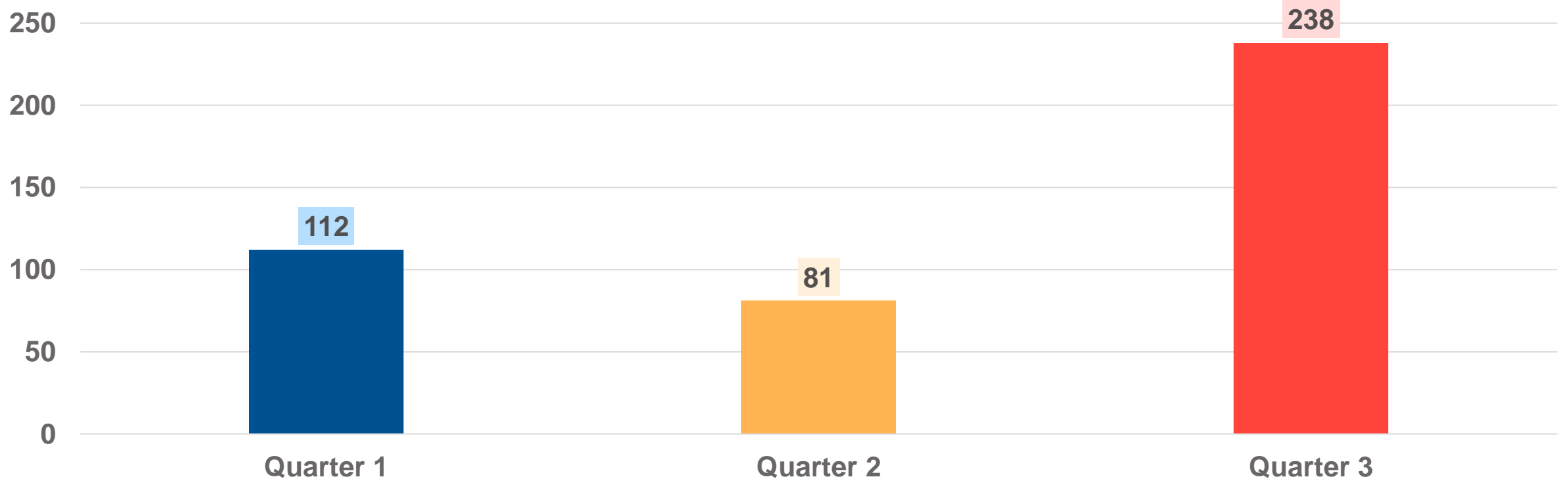

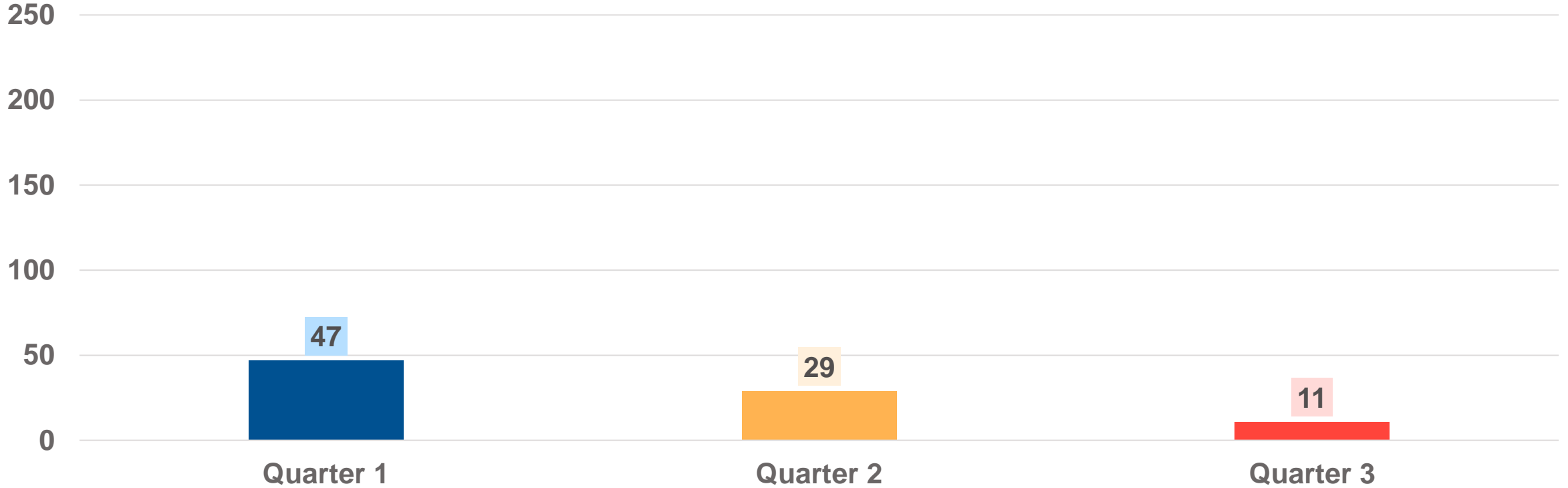

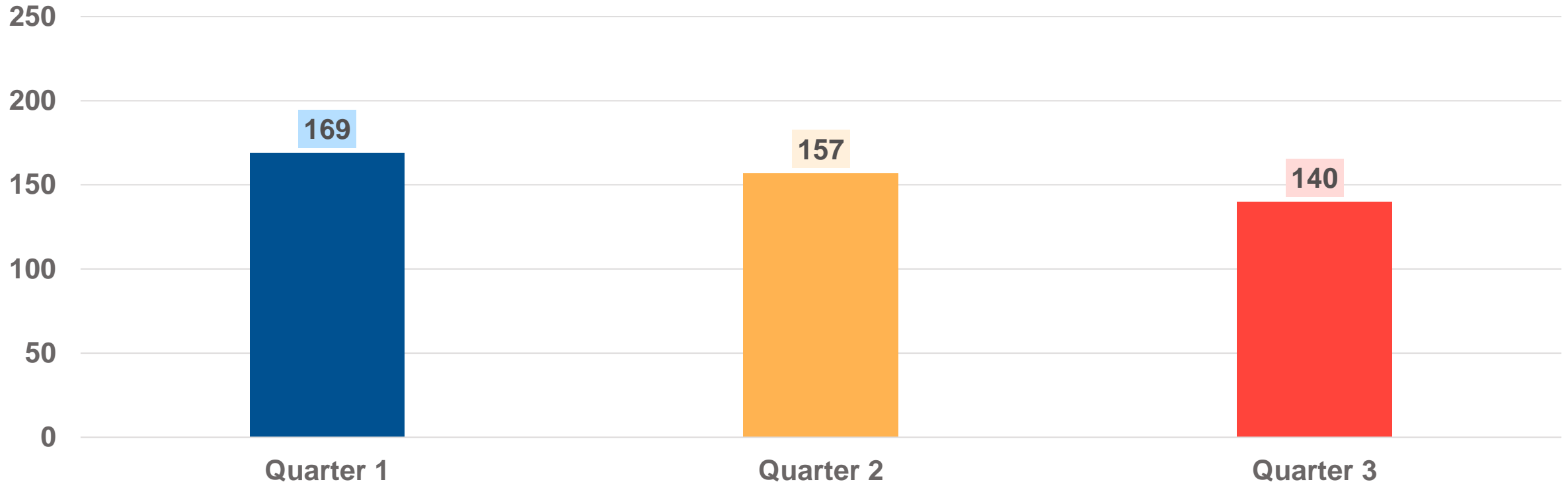

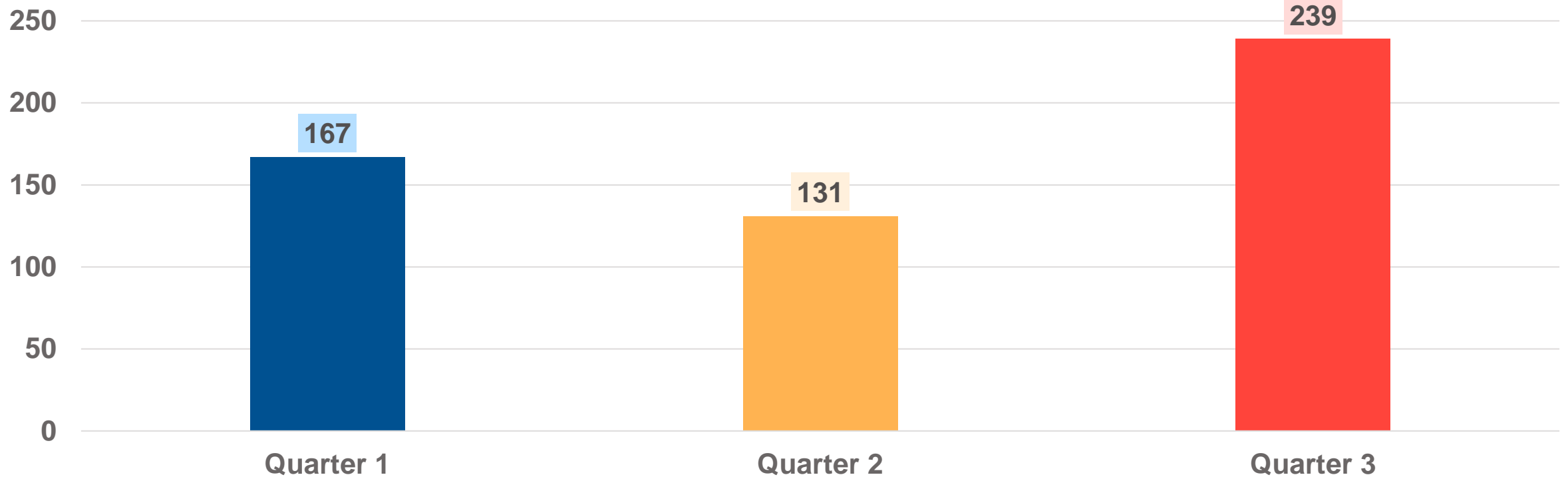

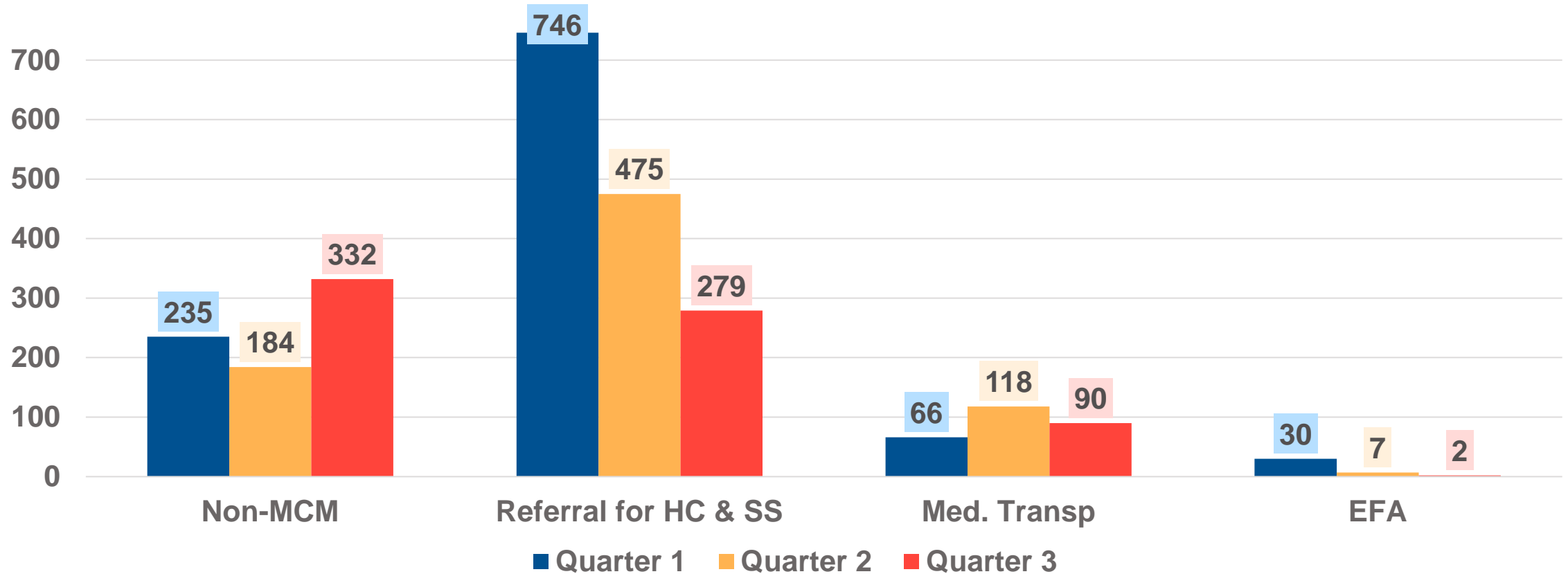

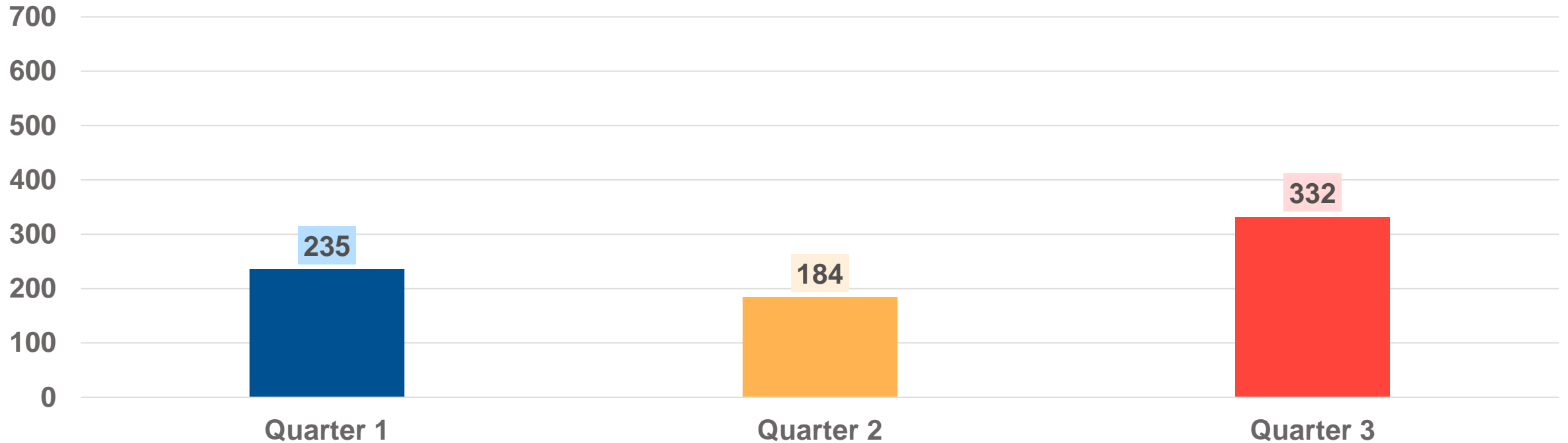

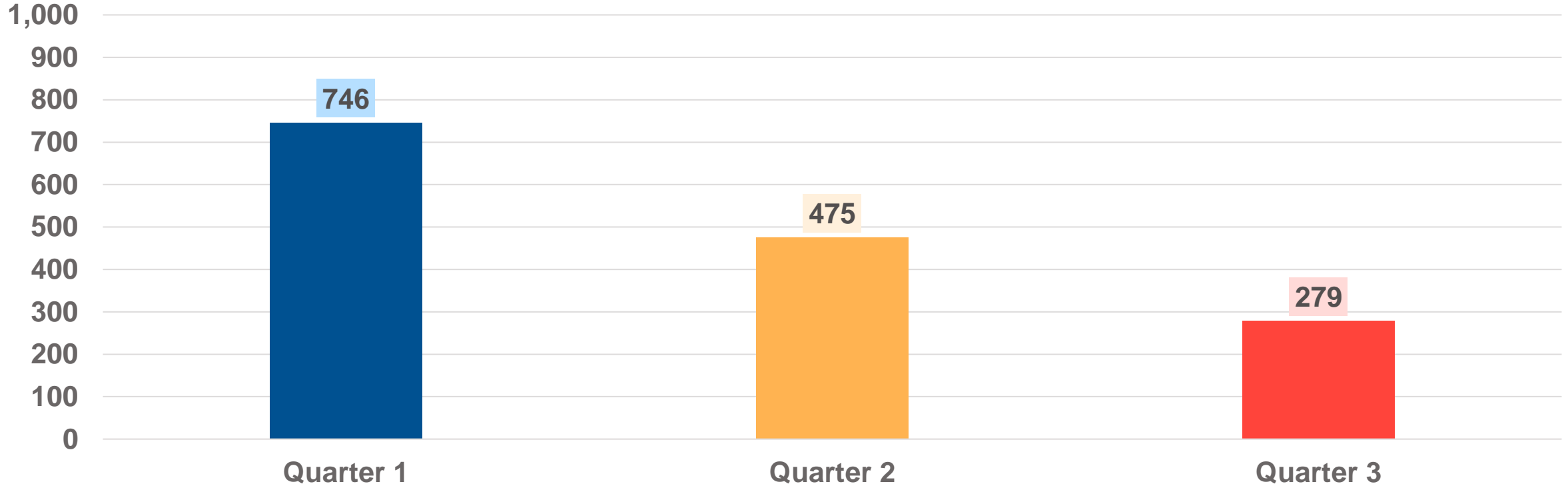

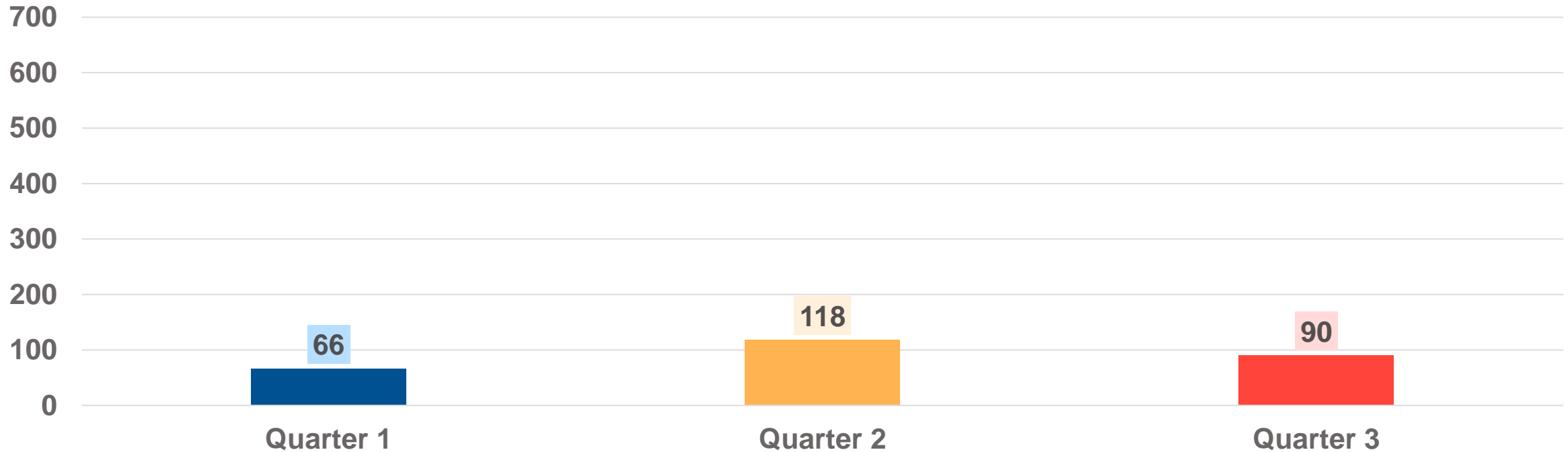

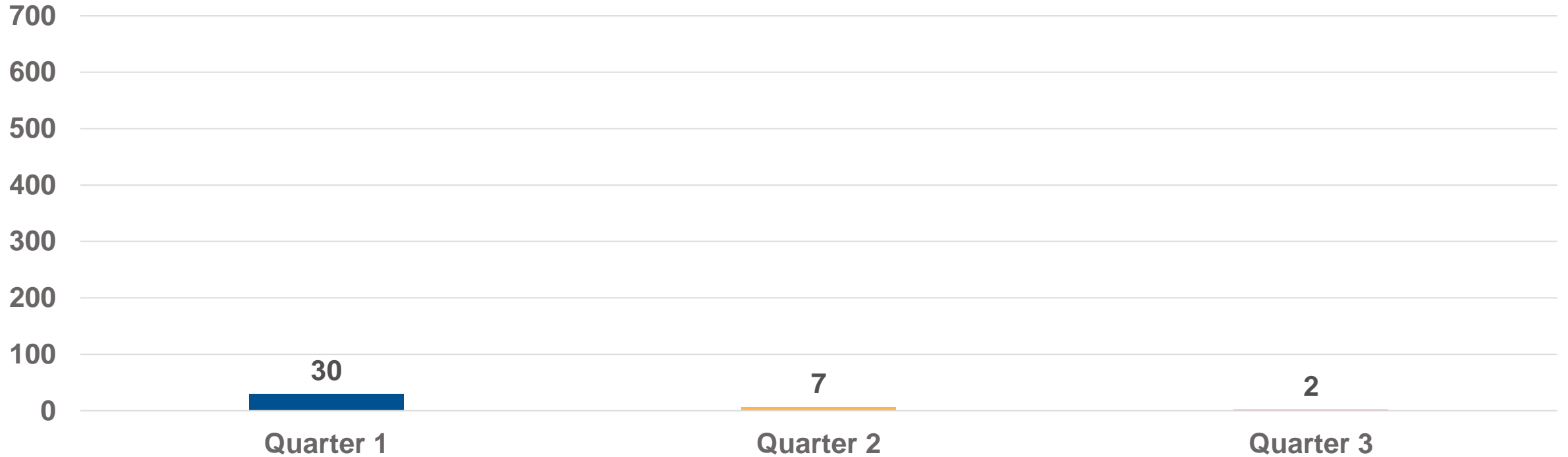
