<p>Reports:</p>	<p>Integrated Plan Ad Hoc Committee</p> <ul style="list-style-type: none"> • The committee reviewed a summary of feedback given at the Integrated Plan Community Engagement Activities conducted thus far. • The committee discussed the Seminole County Community Engagement Activity being a Focus Group instead of a Town Hall. 	<p>focus group will be held at the Seminole County Florida Department of Health on March 31st at 6:00 PM.</p> <ul style="list-style-type: none"> • The committee began discussing goal objectives and activities for the 2027-2031 Integrated Plan. • The committee agreed to hold an additional meeting on March 20th, 2026, and voted to change their meeting cadence to be the 1st Thursday of the month at 2:00 PM. <p>Membership & Engagement Committee</p> <ul style="list-style-type: none"> • The committee reviewed the Planning Council membership matrix and reflectiveness data. There are currently 27 Planning Council members, 48% are PWH, 30% are unaffiliated/unaligned PWH, and 37% are conflicted members. The council currently has one open mandated seat: Representatives of/ or Formerly Incarcerated People with HIV • The committee reviewed the social media performance insights for Facebook and Instagram over the time that the committee last met. • The committee received a Recruitment & Retention update and an overview of the most current Committee and Attendance Rosters. • The committee received updates on the Integrated Plan Community Engagement Activities and the HIV Care Needs Survey. • After some discussion, the committee recommended only reading out housekeeping slides at the start of committee meetings in order to save time. • The committee discussed topics for the May Planning Council Training and the June Leadership Training. • The next Membership & Engagement Committee meeting will be held on Tuesday, April 14th, 2026, at 2:00 PM. <p>Service Systems Planning & Quality Committee</p> <ul style="list-style-type: none"> • The committee received an overview of the Part A, Part B, and GR Monthly Expenditure reports. • The committee received an overview of proposed updates to the Service Standard for Outpatient Ambulatory Health Services. The committee will continue their review of the proposed updates at next month's meeting. • The committee received updates on the Integrated Plan Community Engagement Activities and the HIV Care Needs Survey. • The committee reviewed and recommended updates to the surveys used as part of the Assessment of the Administrative Mechanism (AAM). • The next Service Systems Planning & Quality Committee meeting will be held on Thursday, April 9th, 2026, at 1:30 PM.
<p>New Business:</p>	<p>HIV Stigma Taskforce Anthony McNeil, Captain of the HIV Stigma Taskforce and the Jr. Co-Chair of the Central Florida HIV Planning Council, spoke on the purpose and status of the HIV Stigma Taskforce and the importance of utilizing art</p>

	<p>to engage in the conversation surrounding HIV stigma. He also performed an original poem.</p> <p>ADAP Eligibility Changes Claudia Yabrudy, RWHAP Part A Representative, gave a presentation on the changes to the AIDS Drug Assistance Program (ADAP) that became effective March 1st, 2026 and provided updates regarding recent legislative changes. She also gave an overview of the RWHAP Part A Services that are available as of March 1st, 2026 and answered questions from attendees.</p> <p>Insurance and Medication Access Resources Rachel Klein, a representative from The AIDS Institute (TAI), gave a presentation providing answers to some commonly asked questions regarding the changes to ADAP and answered questions from attendees. She also provided information on an upcoming webinar hosted by TAI and featuring a presentation by Covering Florida regarding assistance with ACA plans.</p> <p>Health Insurance & Medication Coverage Manny Garcia, a representative from All American Benefits, gave a presentation of what services All American Benefits offers as an insurance broker and how they can assist clients facing the changes to ADAP. He also answered questions from attendees.</p>
