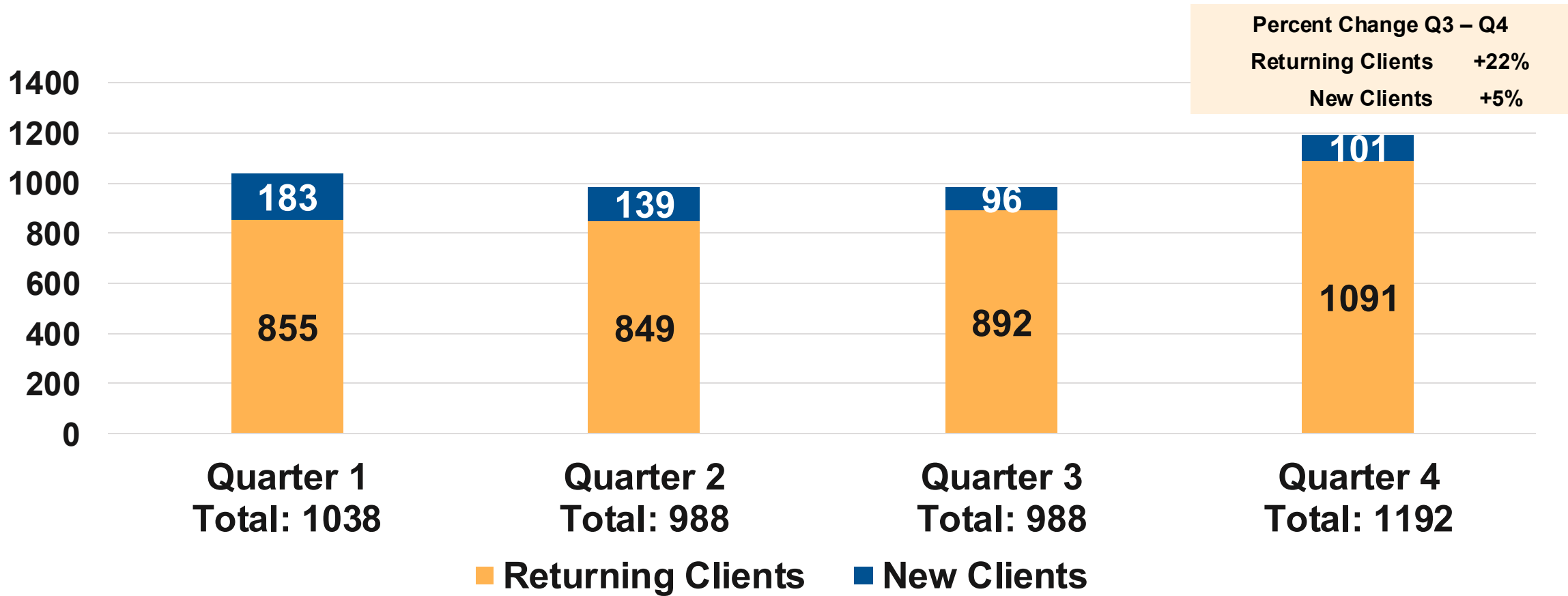

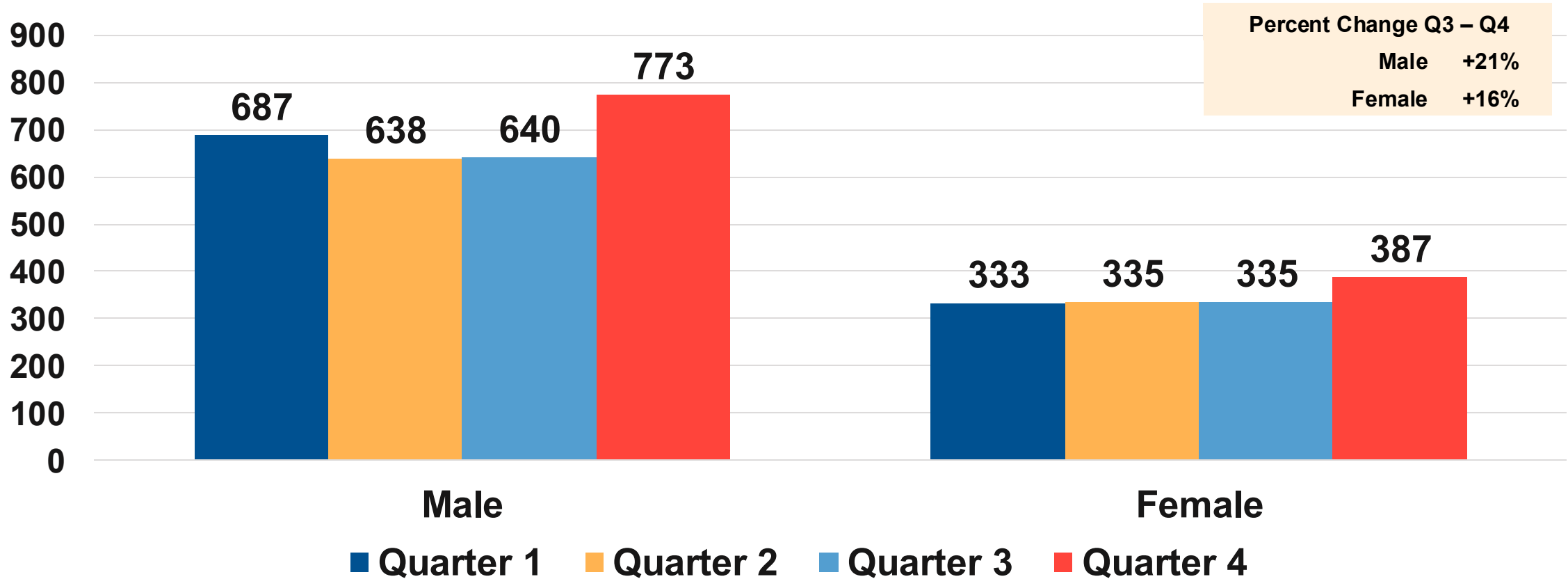

- Data captured is point-in-time.

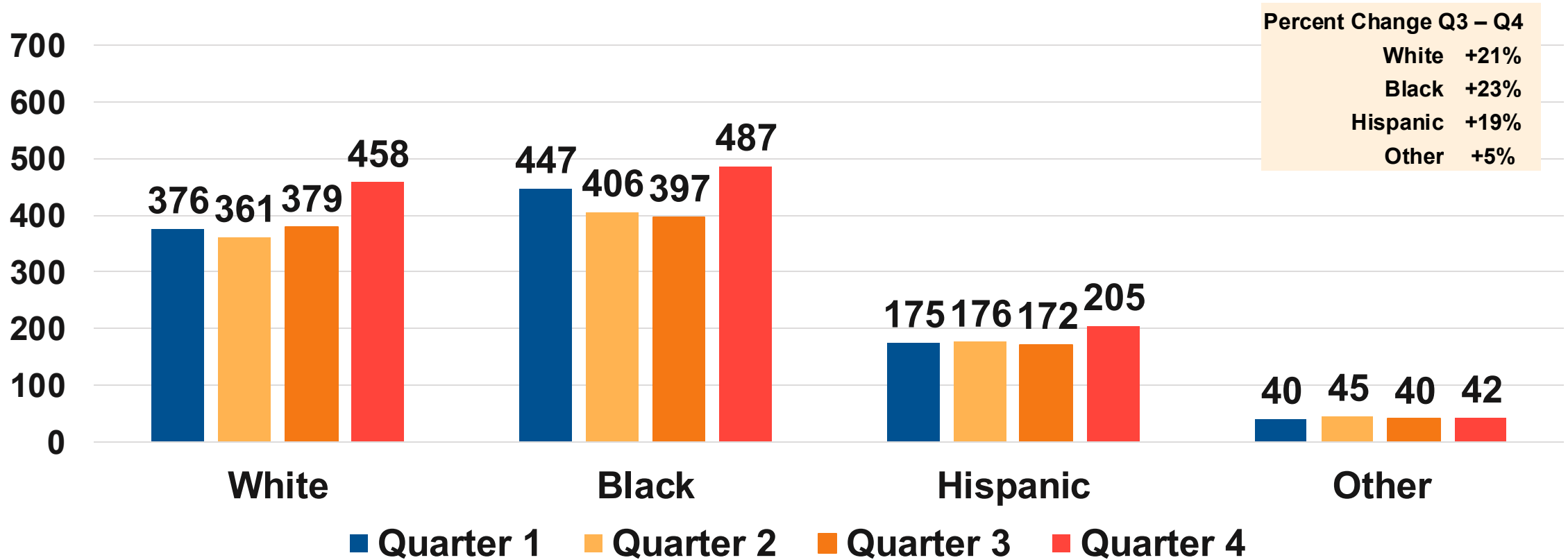

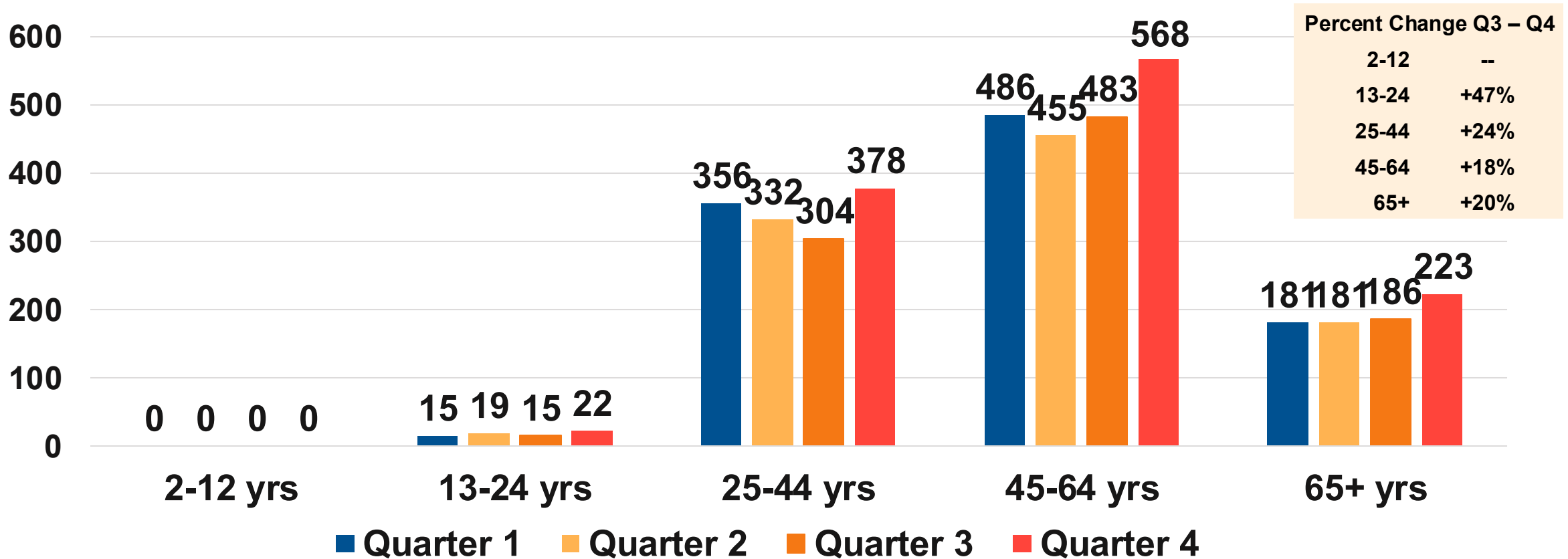
Part B 2025-2026 Quarter 4 Comparison by Sex



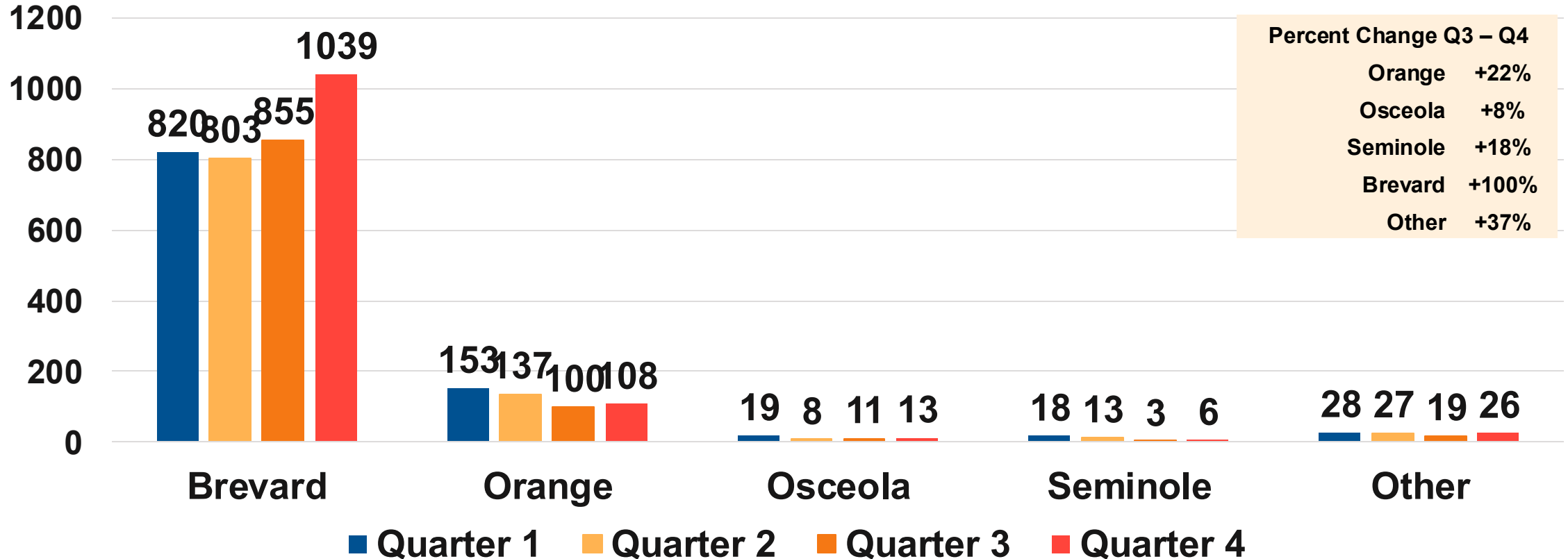
Comparison by Race & Ethnicity



Part B 2025-2026 Quarter 4 Comparison by Age



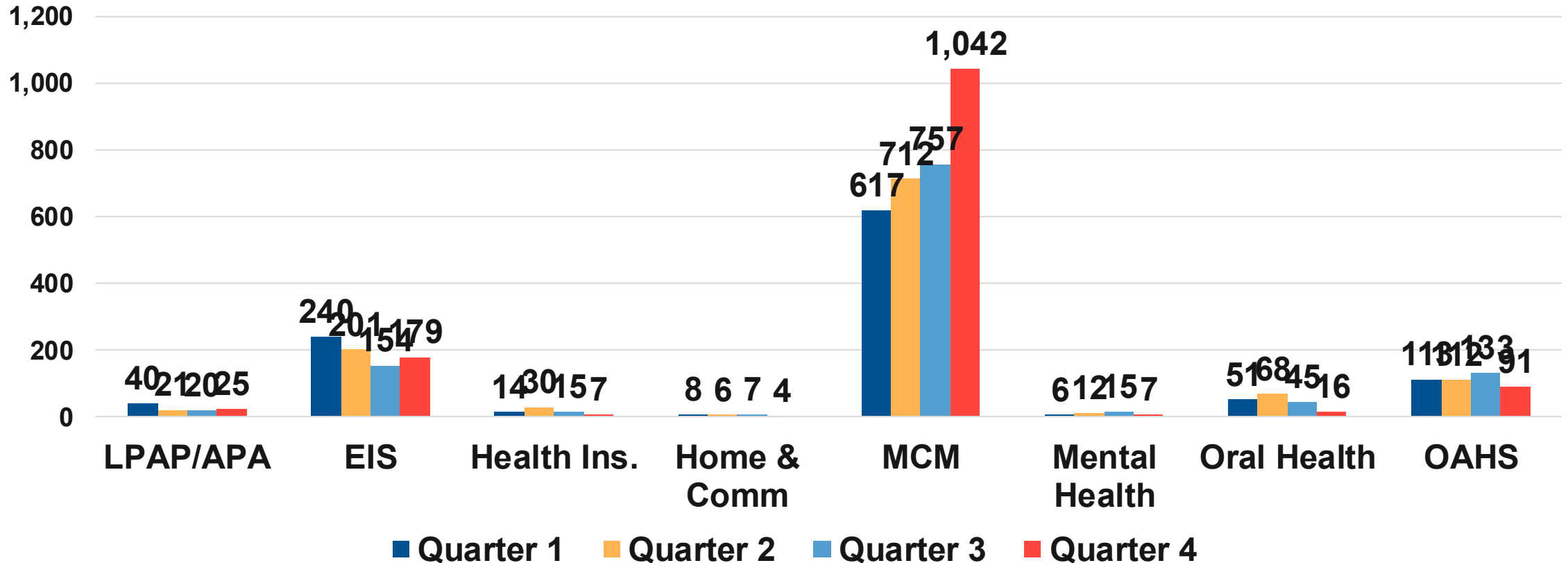
Part B 2025-2026 Quarter 4 Comparison by County



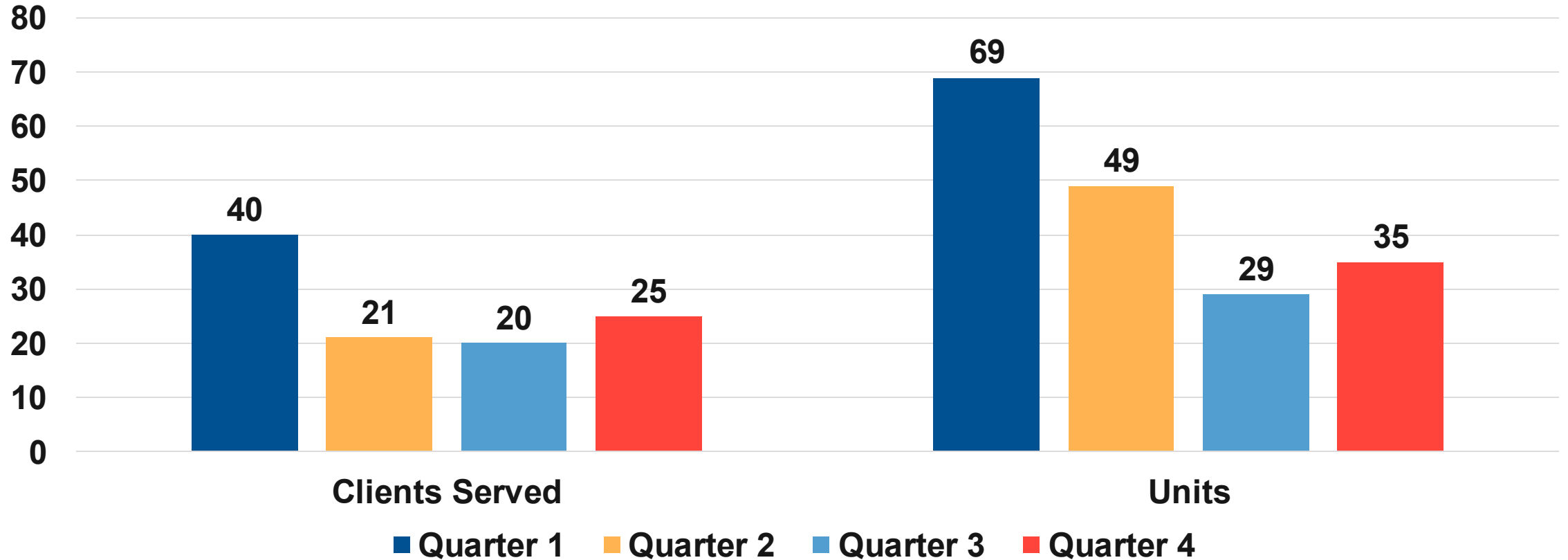

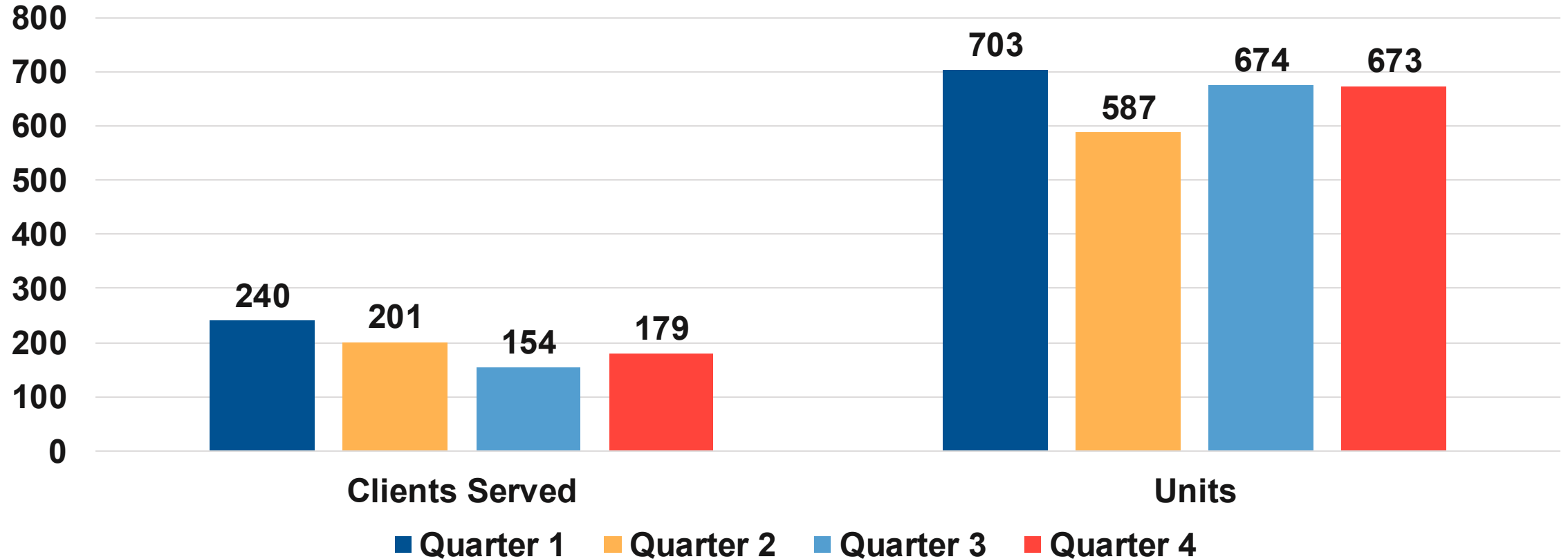


Expenditures based on medications from APA formulary **AIDS Pharmaceutical Assistance (LPAP)**



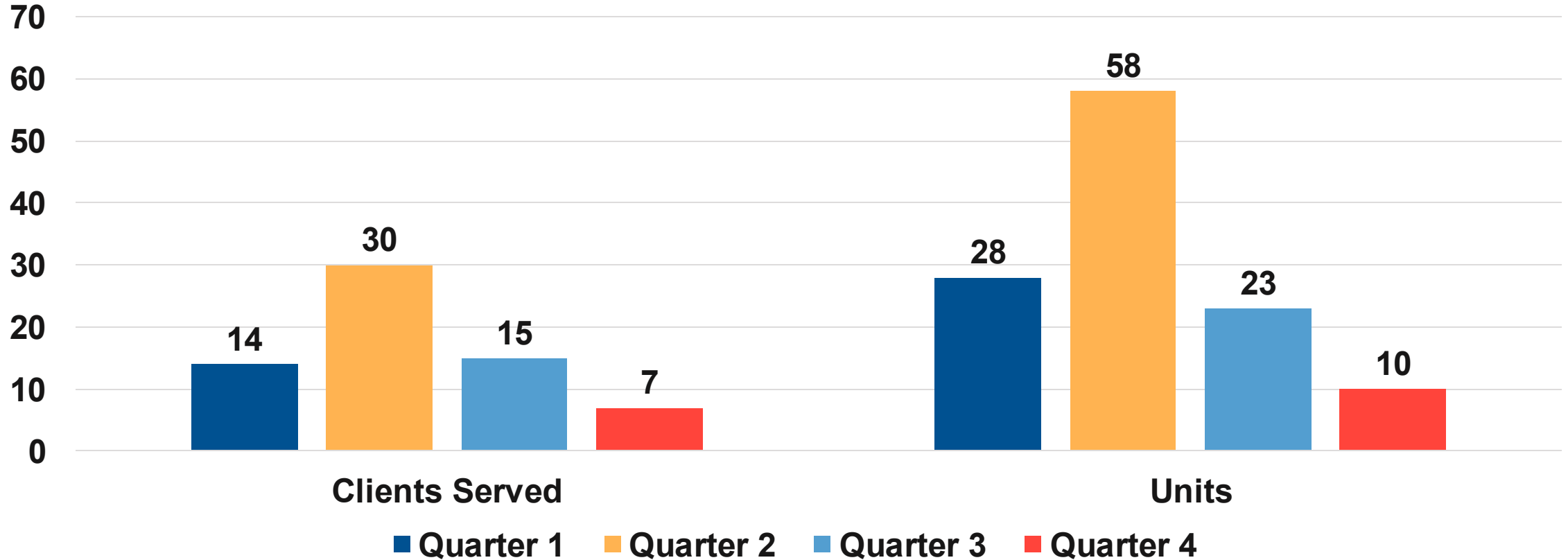

Early Intervention Services (EIS)



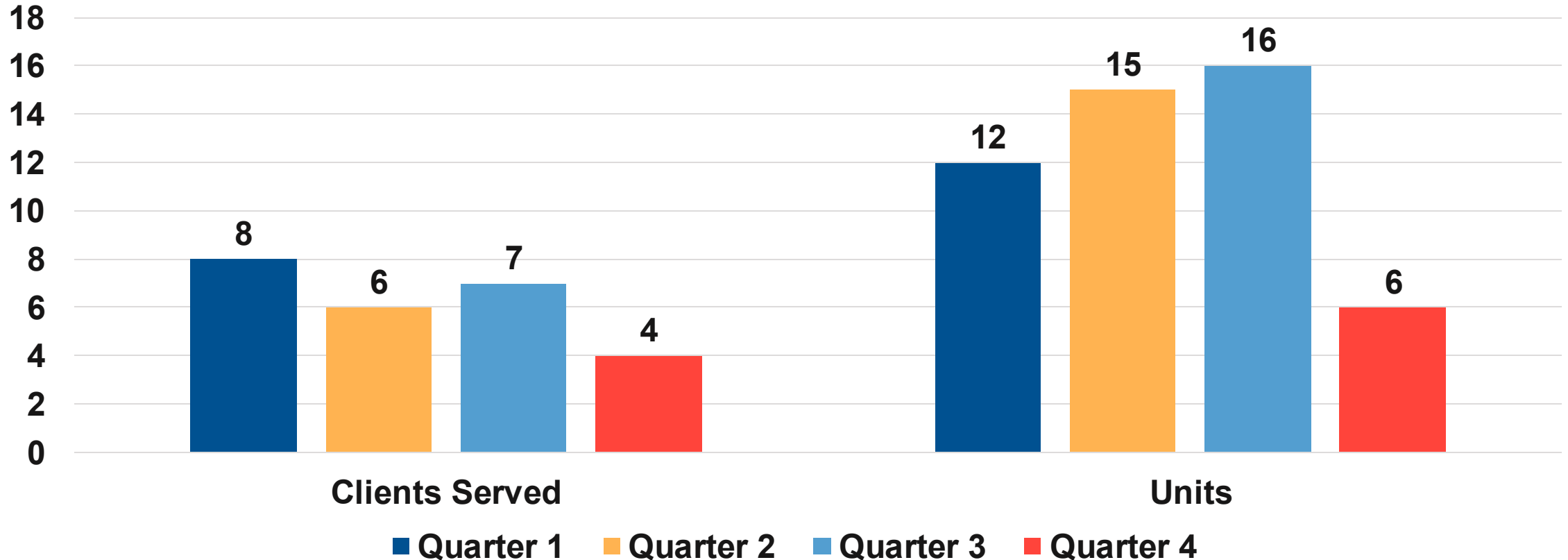

Health Insurance Premium & Cost Sharing



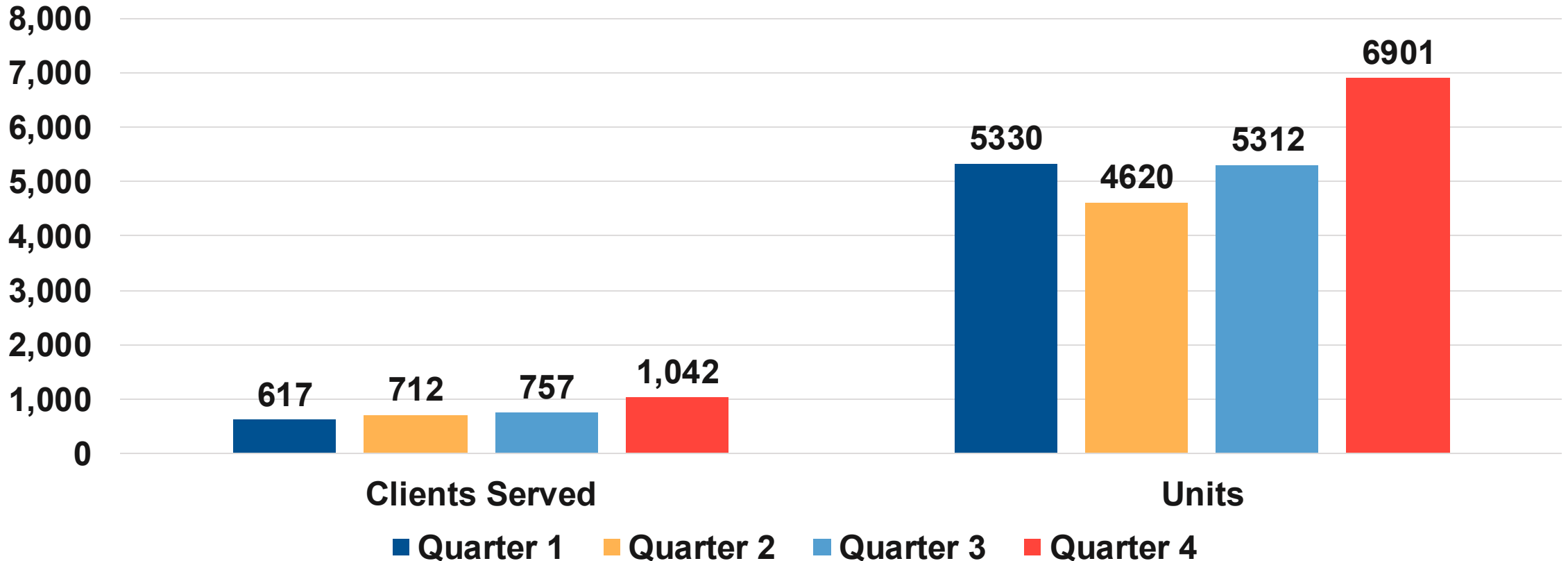

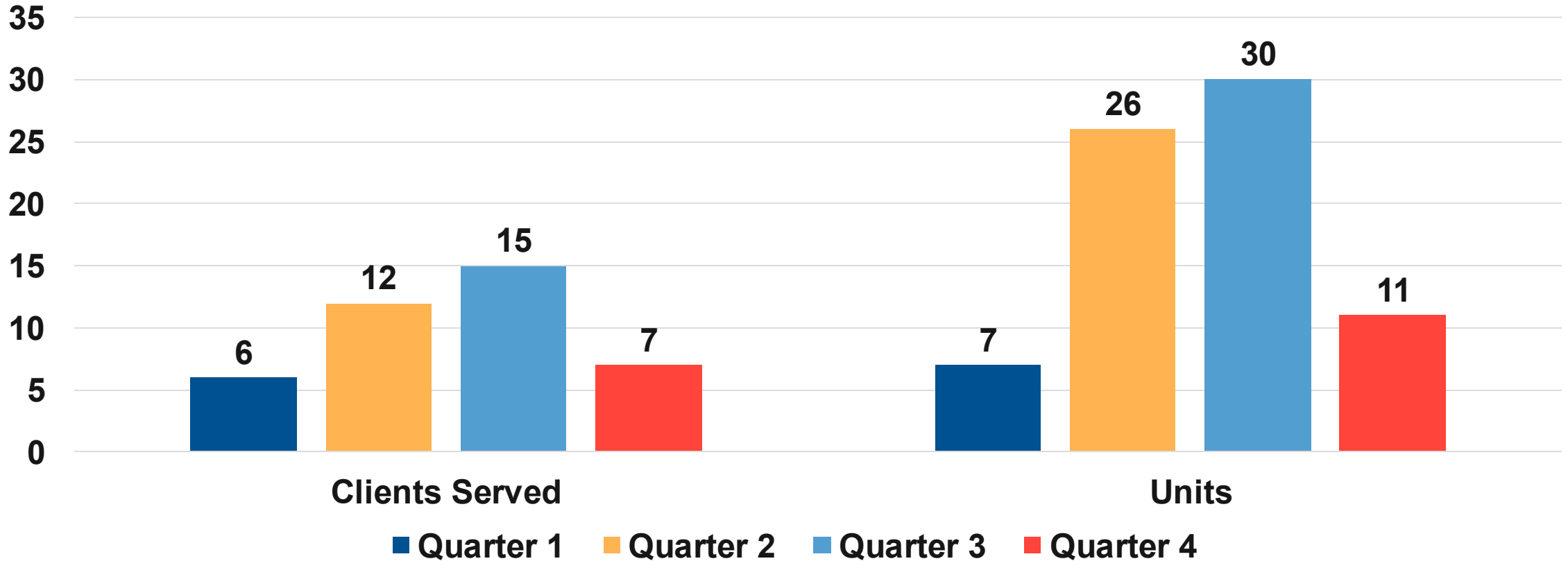

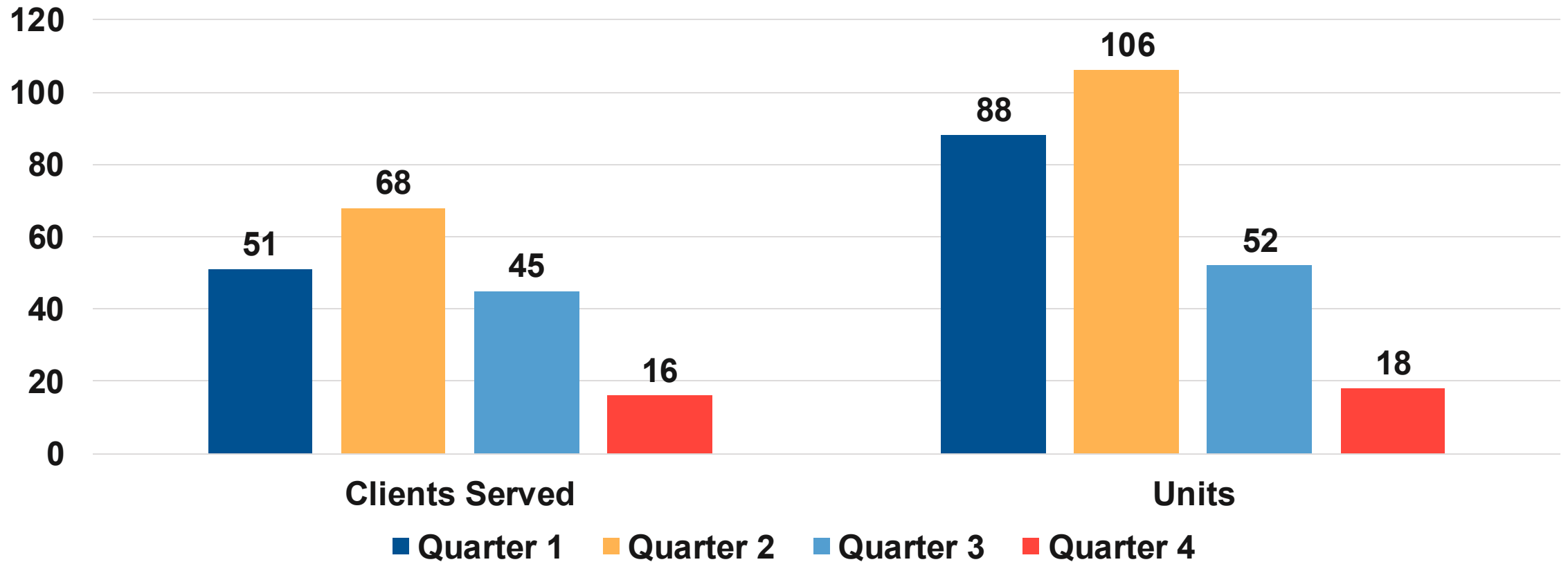

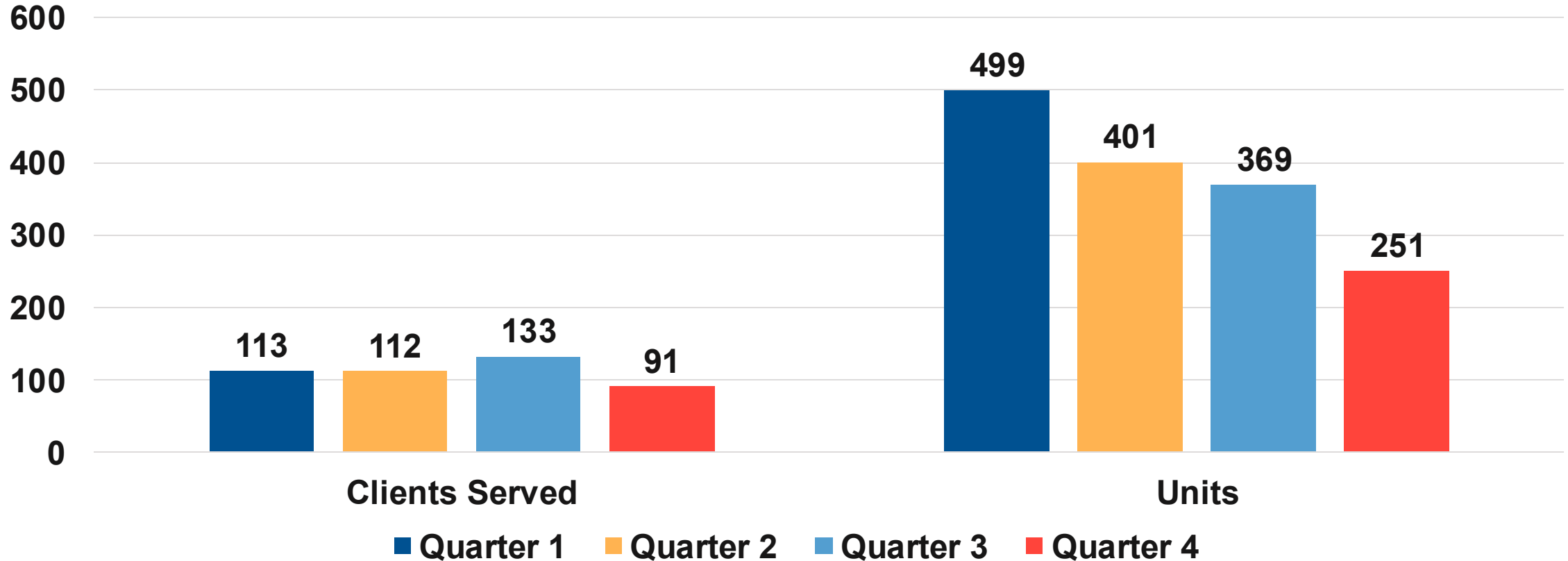

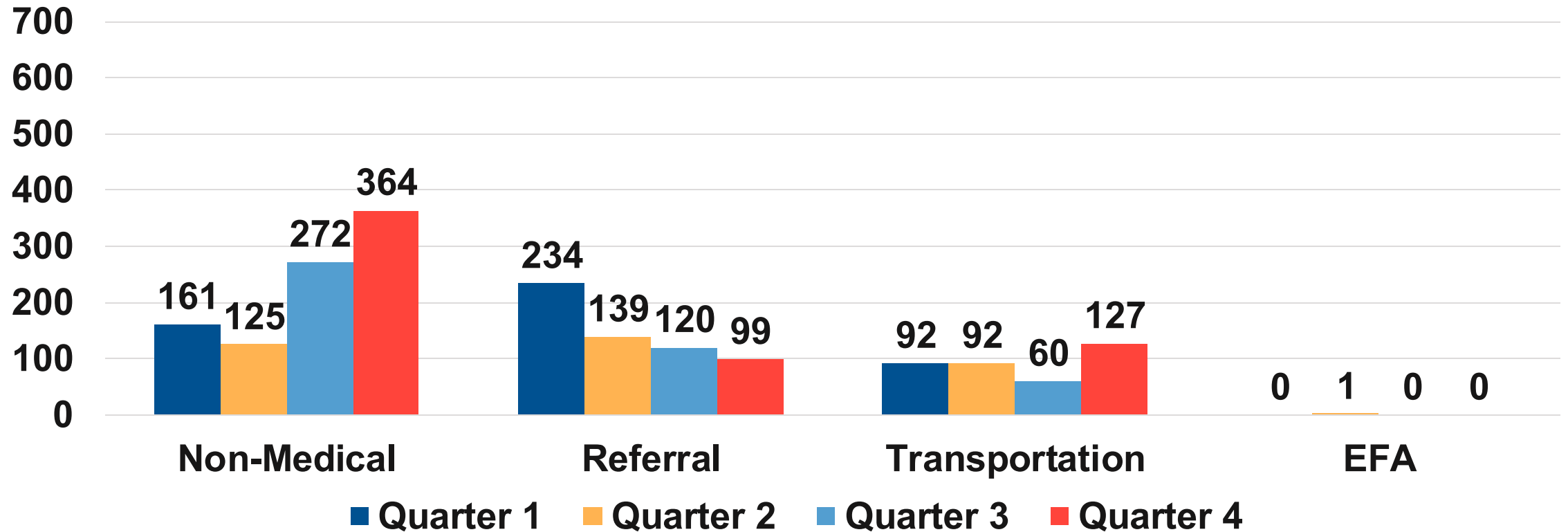

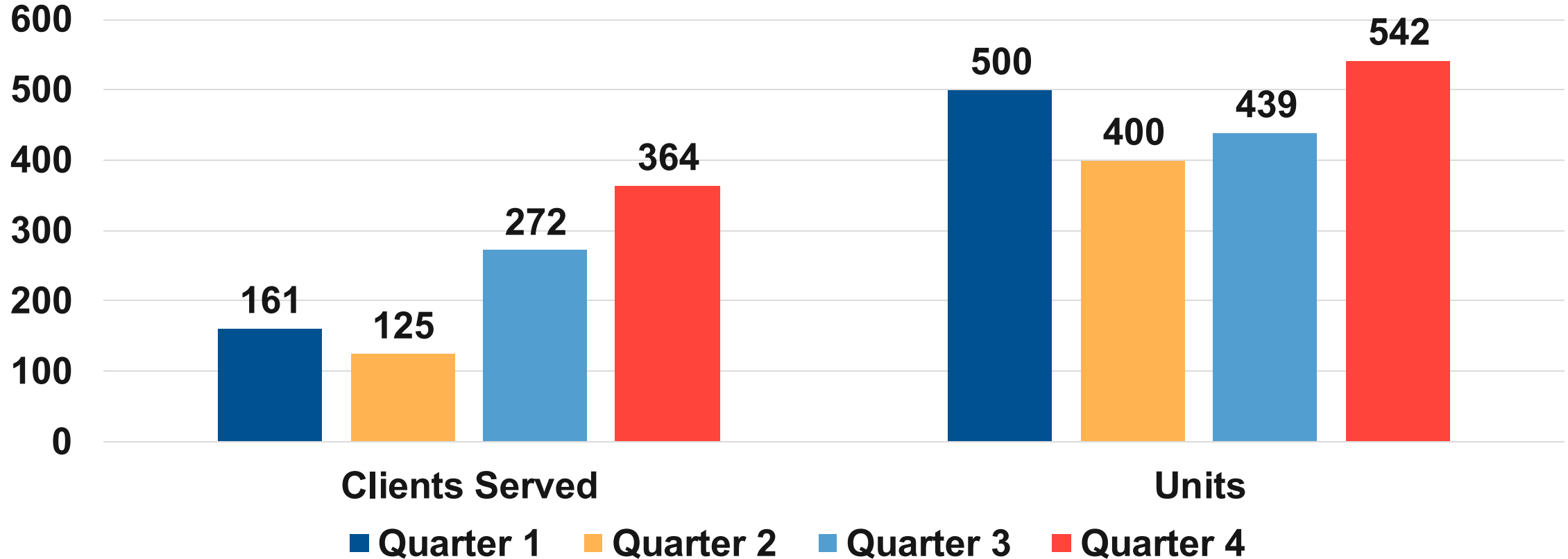

Expenditures based on full-time positions

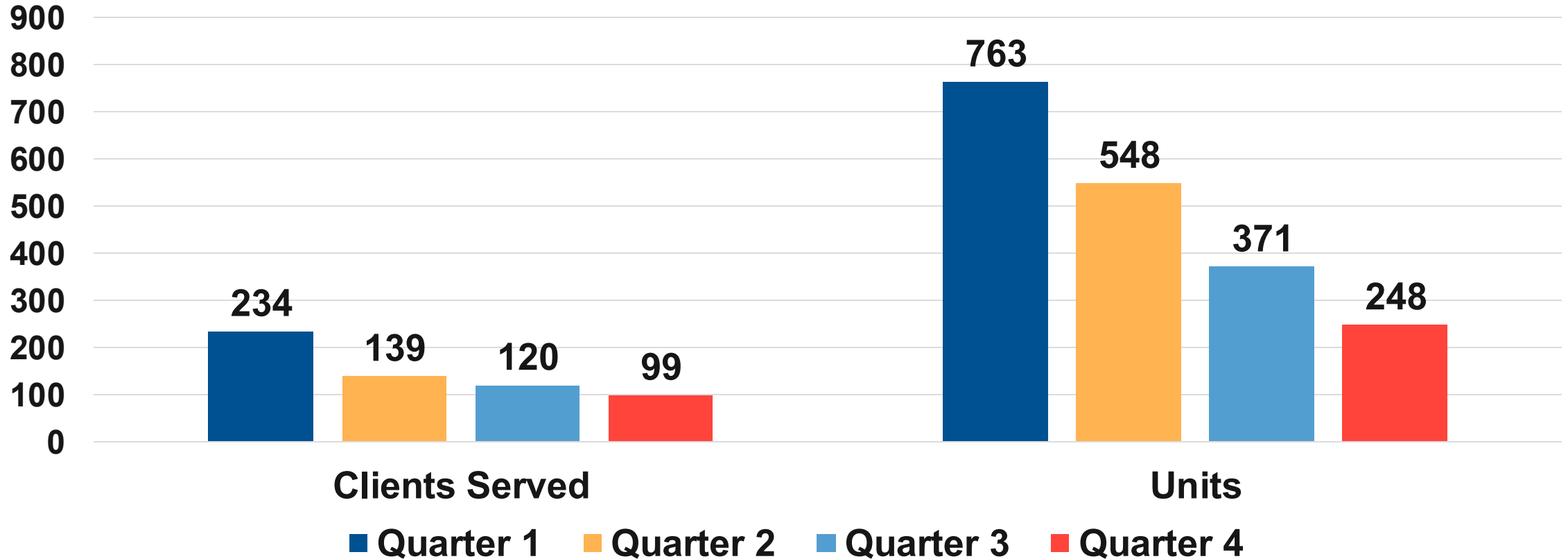

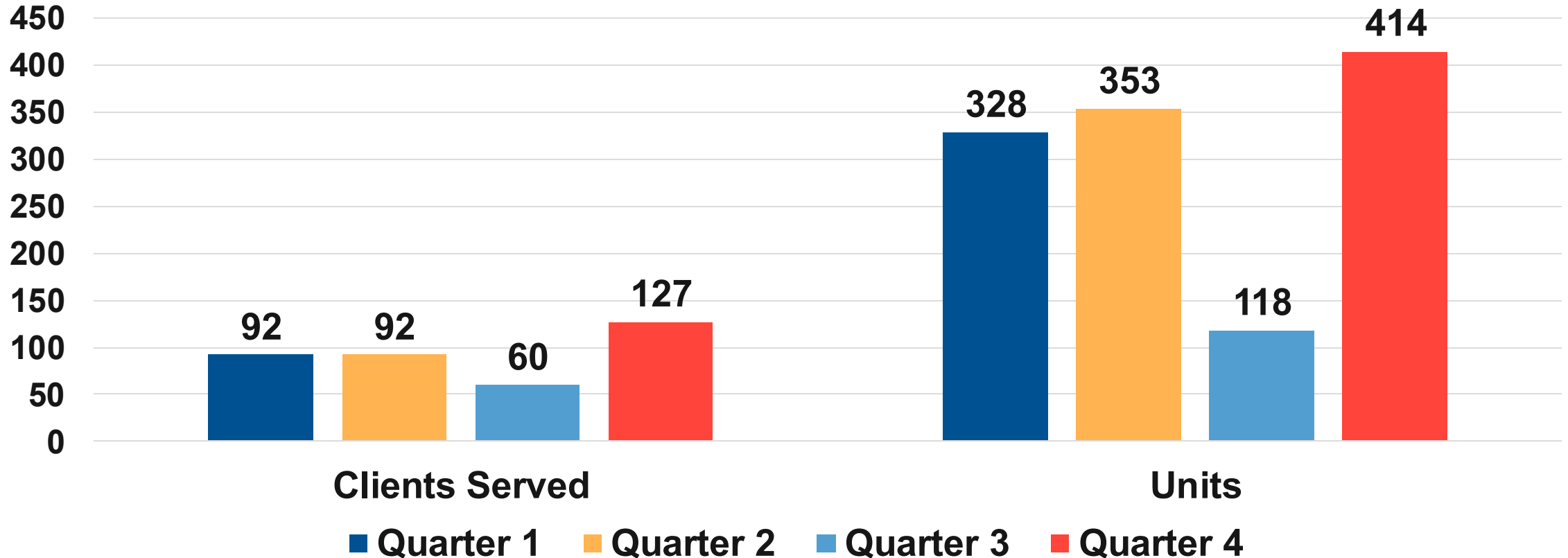

Referral for Health Care & Support Srvs.



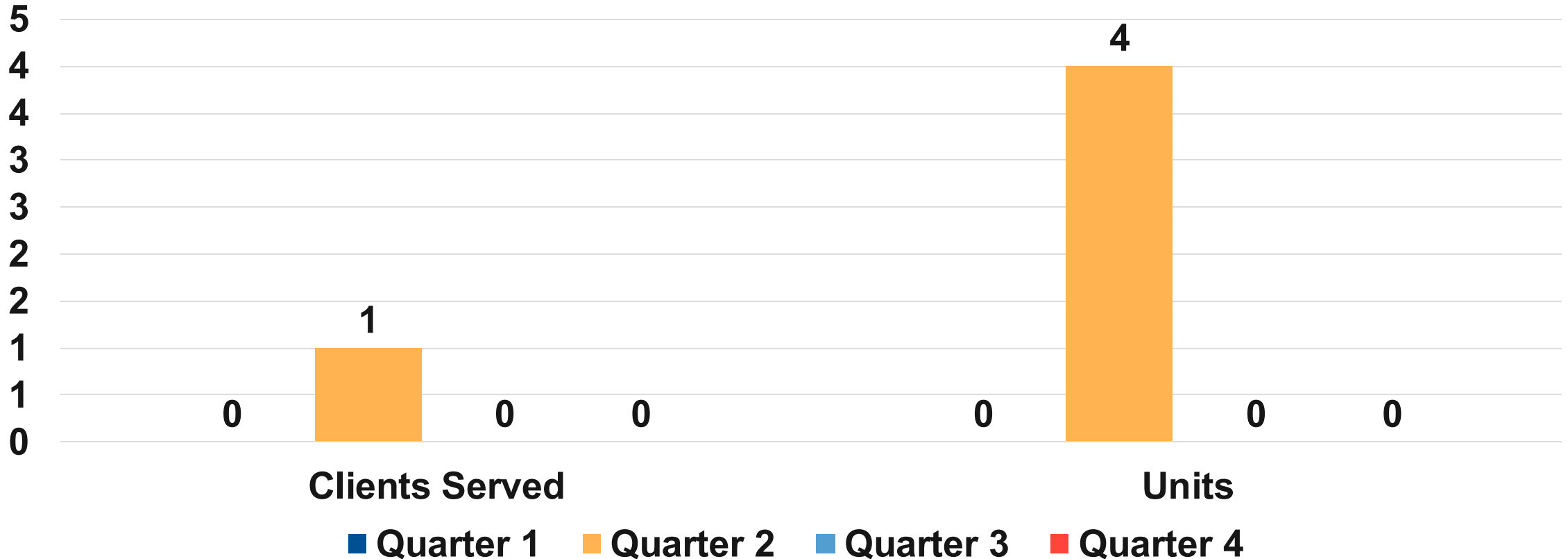
