- Please remember that if you have a personal concern (ex. an issue with an organization) that needs to be resolved, then PCS will connect you with an appropriate RWHAP Part A or Part B representative in the room after the meeting.
- Use the announcement section at the end to inform the Planning Council of upcoming HIV or health-related events in the community.

- A quality continuum of care for all individuals and families with, affected by, and at risk for HIV.



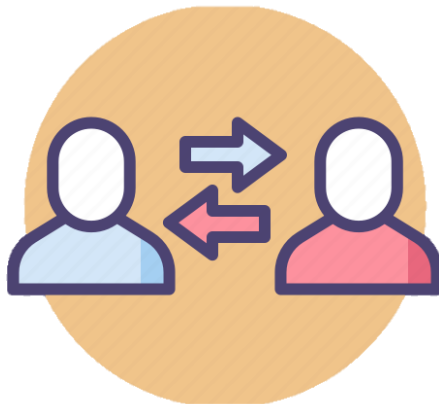
Mission Statement

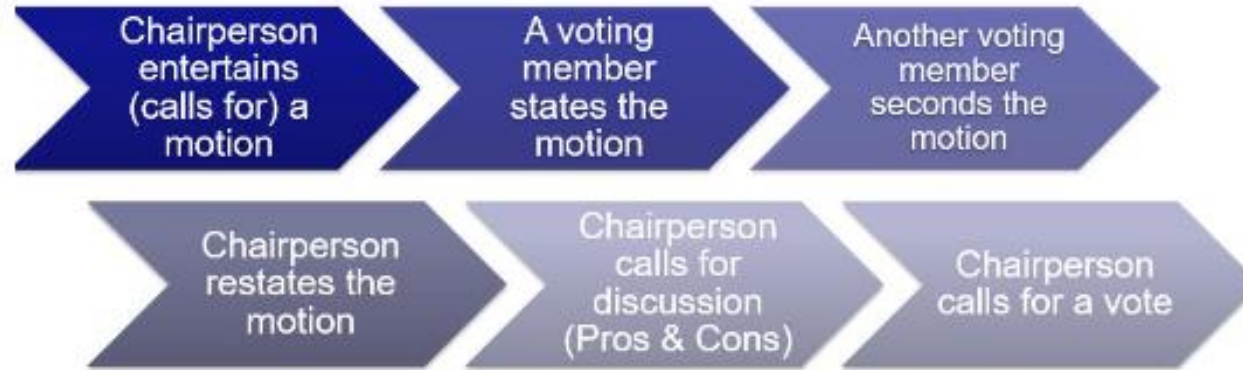


Group Agreement
