

## PC Vision, Mission, & Ways to be Heard

### ***Housekeeping***

- Public comments should be related to items that pertain to the agenda that are within the Planning Council's authority to address and/or duties of the Planning Council.
- Please wait to be called on by the Chairperson.
- There is a 3-minute maximum for comments.
- Please remember that if you have a personal concern (e.g., an issue with an organization) that needs to be resolved, then PCS will connect you with an appropriate RWHAP Part A or Part B representative in the room after the meeting.
- Use the announcement section at the end to inform the Planning Council of upcoming HIV or health-related events in the community.

### ***Ways to Be Heard & Public Comment Expectations***

- *Before/After Meetings*

  - Face-to-Face meeting (before or after meetings or at a scheduled time)
- *During Meetings*
  - Public Comment Section (refer to the above guidelines)
  - Announcements at the end of the meeting
- *Other Ways to Be Heard*
  - Participate in any open surveys

7. Remember that everyone has different passions, experiences, barriers, and communication styles. Respect others always.
8. Be mindful of others' learning styles and processing ability.
